ORDER

UPON the application of the Respondent by way of Inter-partes Summons filed herein on 3rd January 2017 (“the Summons”)

AND UPON reading the Affidavit of Lam Sau Kwong filed herein on 4th

January 2017 together with the exhibits referred to therein and the Affirmation of Lui Pui Chung filed herein on 3rd January 2017

AND UPON reading the letter from the Official Receiver dated 4th January 2017 and the letter from the Secretary for Justice dated 5th January 2017

AND UPON hearing counsel for the Petitioner, counsel for the Respondent; and the Official Receiver and the Secretary for Justice being absent

IT IS ORDERED that :-

1. Subject to compliance with the condition in paragraph 2 below, the *ex parte* Validation Order of the Honourable Mr. Justice Anthony Chan J dated the 28th December 2016 (the “**ex parte Order**”) be continued until the determination of the Petition filed herein on 4th November 2016 or until further order, save that paragraph 1(2) of the *ex parte* Order shall read “*dispositions of the property of the Respondent made in the ordinary course of business for proper value*”;
2. The Respondent shall pay into Court within 7 days the sum of HK\$14,284,627;
3. The Respondent do pay the Petitioner’s costs of and occasioned by the application for the *ex parte* Order and the Respondent’s Summons dated 3rd January 2017, including the hearing on 6th January 2017, such costs to be paid forthwith on an indemnity basis to be taxed if not agreed; and

4. Liberty to apply.
