1. The 1st Defendant do within 21 days from the date of this Order file and lodge with the Court an account of all benefits and/or profits which the 1st Defendant has obtained from the Gift of HK\$20,000,000 (as defined in paragraph 18 of the Statement of Claim filed herein on 17 September 2014) since it was transferred by the Plaintiff to the 1st Defendant on or about 17 December 2007 (“the Account”), in accordance with paragraph 1(4) of the Order of Deputy High Court Judge Seagroatt dated 13 July 2016 and paragraph (4) of the Judgment of Deputy High Court Judge Seagroatt dated 13 July 2016, together with an affidavit duly verifying the Account (“the Affidavit”) and within the same period serve a copy of the Account and the Affidavit on the Plaintiff;
2. The hearing of the Plaintiff’s Summons be adjourned with liberty to restore for the parties to apply for further or other directions with regard to the taking of the Account;
3. Costs reserved.
