Re: High Court Action No. 1619 of 2014

As you are well aware, your client amended his Statement of Claim to include libel as one of causes of action in the above Action.

We enclose herewith a copy of letter dated 24 August 2016 from your client about the 5<sup>th</sup> Defendant's doctoral degree received by the 3<sup>rd</sup> Defendant. This letter was sent to many parties as stated on the letter. The letter stated that the 5<sup>th</sup> Defendant's doctoral degree is "false". Such allegation was stated in the Amended Statement of Claim and is denied by our clients. Therefore this matter is still an issue to be decided by the Court.

In law, any form of publication which are intended or likely to interfere with or obstruct the fair administration of justice are punishable as contempt of court. The offence is committed when the publication is likely to prejudice the fair trial or conduct of criminal or civil proceedings or the publication prejudice issues in pending proceedings. For a publication to amount to a contempt, it is not necessary to show that it actually prejudice a fair trial or the conduct of the proceedings. It suffices when there is a real risk of prejudice.

Further, comments on pending proceedings, emanating from the litigation parties are generally a more serious contempt than those coming from independent sources.

We take the view that the letter contains allegations by your client which have the effect of deterring or inhibiting parties in the conduct of their proceedings by prejudicial discussion of the merits or facts of the case before the proceedings have been determined by a court of law.

The seriousness of the allegation is also exacerbated by the fact that a libel case can be tried by jury and such prejudging issues is likely to influence potential jurors.

We hereby give your client notice that unless your client sends another letter to the recipients of the open letter withdrawing the said allegation and undertakes not to make any further publication of the issues of the Action in public until final adjudication of the Action, contempt proceedings will be taken against your client without further notice.
